

Sioux Falls Sourced Box 2026 Sweepstakes Official Rules

The following sweepstakes is intended for viewing in the 50 United States and shall only be construed and evaluated according to United States law. No purchase necessary. Void where prohibited by law. Participation constitutes entrant's full agreement and acceptance to these rules.

The Sioux Falls Sourced box promotion ("sweepstakes") is hosted by Experience Sioux Falls ("administrator"). The sweepstakes is open to legal residents of the 50 United States who are at least 21 years of age and have a physical address in the United States. This promotion is governed by US law and is subject to all applicable federal, state and local laws and regulations. Employees of Experience Sioux Falls and parent companies, affiliates, subsidiaries, advertising, promotion and fulfillment agencies and members of the immediate family or household of each are not eligible to participate. Immediate family member is defined as a parent, sibling or any person residing in the same household as an employee.

The sweepstakes begins on May 15, 2026 and ends on November 15, 2026 at 11:59:59p.m. CST ("sweepstakes period"). During each phase, one-hundred (100) winners will be randomly selected to receive a Sioux Falls Sourced box ("prize"). The time periods for each phase will be the following:

- Phase 1 Summer Box: May 15 – August 31, 2026
- Phase 2 Fall Box: September 1 – November 15, 2026

Visitors to the promotion may register at ExperienceSiouxFalls.com/Sioux-Falls-Sourced. Participants must register during each phase to be eligible to win that specific box. Multiple entries will be accepted, but it does not increase your chances of winning. Eligible participants can only win one box for the duration of the promotion. Participants will be asked to provide their first name, last name, email address, birth date, city, state, zip code, and travel interest. Prize Winners information will be available by the 15th of each month following each phase. Once participants have finished the registration process on ExperienceSiouxFalls.com/Sioux-Falls-Sourced, they will be officially entered to win prize. All entries become the property of Experience Sioux Falls and will not be returned.
